- 5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Municipal Buildings, West Street, Boston, Lincolnshire, PE21 8QR by 5 pm on Tuesday, 18th April 2023.
- 6. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Tuesday 25 April 2023. You must be registered to vote before you apply for a Voter Authority Certificate.
- 7. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Municipal Buildings, West Street, Boston, Lincolnshire, PE21 8QR by 5 pm on Tuesday, 25th April 2023.
- 8. Deadline for the issue of temporary Voter Authority Certificates is 10pm Thursday 4 May 2023, the person must have already applied for a Voter Authority Certificate by 5pm Tuesday 25 April 2023. The temporary Voter Authority Certificate can only be collected by the applicant in person.
