- a) Dwelling with a floor area exceeding 300m2
- b) The number of dwellings that form a single application exceeds 2.
- c) The proposed work does not fit into any of the aforementioned categories/ relates to more than one building.
- d) The duration of the building work from commencement to completion will exceed 12 months.

2. An additional charge is payable where relevant electrical work is undertaken by persons not registered in a relevant competent person scheme. The additional charge per dwelling is in accordance with Category 11a or 11b, Table B.

3. Where more than one extension forms part of the same application, and are to be built at the same time, the floor areas can be added together and a single charge paid based on the total floor area.
